## TERMS & CONDITIONS

- Exhibitor shall keep the Premises, including booth, table or other items as Exhibitor may have in a neat, clean and attractive condition
- Electrical cords must be secured/covered.
- No subletting booth space
- No signs or other obstructions to view existing merchants or other exhibitors. No bright lights, music or loud noises will be permitted that disturb others
- No Parking in driveways, fire lanes and loading zones. Exhibitors must park in designated parking areas. Violators shall be subject to ticketing or towing.
- Trash is to be disposed of in the appropriate receptacles located outside the service entrances. Boxes must be flattened. Do not use common area receptacles.
- Management reserves the right to re-locate an exhibitor as required.
- NO HELIUM BALLOONS ARE PERMITTED.
- Hawking is prohibited at all times!
- LICENSES - Any and all City, County, Municipal, State or Federal licenses, inspections or permits as required by law of any Exhibitor in the installation or operation of his display shall be obtained by the Exhibitor and provided to Show Management at Exhibitor's own expense prior to the opening of the show.
- INSURANCE - During the term of this Agreement, exhibitor shall procure and maintain Comprehensive General Liability insurance, which shall include contractual liability coverage, with limits of not less than \$1,000,000 per occurrence for bodily injury and property damage, combined single limit. A certificate evidencing workers' compensation insurance is required, unless Exhibitor is subject to exemption.
- I agree and acknowledge that Show Management has no obligation to provide workers' compensation coverage in the event that it is determined that any individual providing services for the Exhibitor is an employee or eligible for workers' compensation insurance. I agree to indemnify and hold harmless Show Management from any loss, injury, claim, damage, liability, cost, penalty, award or expense of any kind, arising, directly or indirectly, from any breach of any of the representations and warranties made in these Terms and Conditions.
- SECURITY - Neither show management, venue, or respective insurance companies are responsible for any financial losses or disappearances of any kind.
- Exhibitor hereby consents to Show Management's royalty-free use of visual and audio reproductions of Exhibitor and its employees and exhibit(s) including without limitation recordings, photographs, video tapes, films and other images or likenesses for the purpose of Management's advertisement and promotion of this and future shows.
- ALL EXHIBITS MUST REMAIN SET UP UNTIL CLOSE OF SHOW
- SET UP AND TEAR DOWN – Set up of the show shall occur before mall hours. Deliveries through the common area shall occur before 9:30 am on the day of the event. Exhibitors shall be completely set up by 9:45 am the day of the event. All carts and dollies used for delivery are required to have pneumatic tires.
- Tear down of the event shall occur immediately after 4 pm on January 25, 2020. This process shall occur in the safest manner possible without disruption to surrounding businesses and/or the public. Please use corridors. Corridors will be shown on map provided before the event.
